Dear Friends,

We are writing to ask for your help with a very important event which will benefit our community. Our hope is that you will take the opportunity to help your neighbors by sponsoring the **5th Annual Greene County Community Cancer Fundraiser, "Walking with Our Neighbors for Our Neighbors" 5K Walk/Run Event**. The Greene County Cancer Fund was established in 2009 to provide assistance to county individuals and families affected by cancer and experiencing financial hardship. It also helps uninsured individuals get needed diagnostic services not covered by the NYS funded Cancer Services Program. Since 2009 we have raised more than \$34,500 and are proud to say that this fund has helped over 60 recipients pay for prescriptions, diagnostic testing, medical bills and some living expenses.

The fund is administered at no cost by The Healthcare Consortium, a community-based not-for-profit agency, which has, as its central mission, increasing access to healthcare.

The Walk will be on **Saturday, May 11th, 2013** in Catskill, NY. The pre-registration fee is \$15 per participant and the **deadline to pre-register is March 29th**; after that date the registration fee is \$20 per participant. The day of the event registration begins at 8:00 a.m. at Dutchman's Landing and the Walk starts at 9:00 a.m. Walkers are encouraged to organize a team and raise additional funds prior to the event. Additionally, a raffle will be held to win a handmade quilt and several other donated items. We would like to encourage businesses to participate in the raffle by donating gift cards, goods or services.

All funds raised will benefit Greene County residents only.

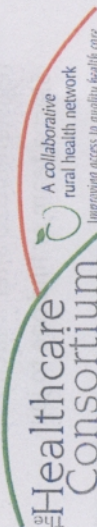
