## **GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS**

1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

Supervisor Ruso opened the Work Meeting at 7:00 PM and the Pledge of Allegiance was said. Also attending Councilmembers Boehlke, Irving and VanEtten; Deputy Supervisor Dellisanti; County Legislator Linger; Town Clerk Finke; and 4 members of the public who signed the attendance book. **Supervisor Ruso:** We have received our second ARPA money, that was a check for \$166,871.28 and we're gonna be depositing into the bank tomorrow. So that's the second and final disbursement of ARPA money that was sent from the Comptroller to the Town.

Office of the State Comptroller: 'Re: Town of New Baltimore, Extension to Water District No. 3  
Dear Ms. Finke: This will acknowledge receipt of the order of the town board of the Town of New Baltimore dated April 11, 2022, extending the above referenced district. The order was filed in the Office of the State Comptroller on April 20, 2022. In acknowledging receipt, we express no opinion as to the validity of the proceedings undertaken by the town in connections with the extension of this district.'

**Supervisor Ruso:** In a lot of ways this district wasn't extended. It was more that some of the parcels were identified as being in District 2 when they were not and they were actually in District 3. So it was a redefinition of what parcels were in what district. Obviously we didn't extend the lines or anything of that nature. So we had some conversations about that back in April. Otherwise the financial reports for June have been forwarded. Has everyone had a chance to review them? I will make a motion to accept the June financial reports. Do I have a second?

***County Legislator Pat Linger***

I told you before, but I do appreciate the ability to come in and give this report every month. I talked to all of our Legislators. There's not a lot of them that do it. So I do appreciate the ability to do that. Earlier this month, we held Special Legislature meeting #3, where we authorized the sale of Exit 21 East property to the IDA for development. This will allow for subdivision of 3 parcels and a roadway into the property from Rt. 23B. Stewarts is expected to be the first to purchase property to move their shop across the road. At this time, there are no commitments for the other parcels, but we hope to see a hotel and restaurant or small retail store developed here. One more project moving forward is the new Justice Center planned for the former jail site. We awarded the Construction Management contract to Freeman Project Services of Cairo. We expect to be able to put this project out to bid over the winter and begin construction next spring. We continue to work with CMH on the Exit 21 West project, which will also house our Community Health Center. This is expected to include mental health, public health, and veterans services. We set the CGCC budget public hearing for 8/17 at 6:25pm. This year we will see a \$206k reduction in that cost, based on 2021 student population. Due to state mandates to provide nutrition and an extreme shortage of meals on wheels volunteers, we are looking at contracting with Moms Meals for approximately 60 seniors we have on a waiting list. Volunteers are always needed and you can contact Ruth Pforte at Human Services for more information on how to volunteer. We authorized contracts for SRO's with all school districts except C-A. They have indicated they may wish to contract with the Sheriff for the upcoming school year as well. That would put at least one specially trained SRO in each district in the County. It has been an extremely successful investment since inception just a few short years ago. We authorized a \$60k one-time grant to library association for wifi upgrades. Early voting for Congressional and NYS Senate primaries, as well as the Special Congressional election, will begin on August 13. Once again, this will be another unfunded mandate from the State, as the original districts developed by the State Legislature were declared unconstitutional. Each election has a cost of roughly \$10k, and we will have 3 this year. This cost is then split between our 14 towns and

voted on as a chargeback. I will again vote against that chargeback. As expected, we are beginning to see signs of economic slowdown and inflationary effects in sales tax receipts. Coxsackie Transfer Station construction costs have again increased. We are now up to a total cost of \$2,128,863 from initial estimates of \$1,073,157. We still expect to recoup that cost, albeit at a longer ROI period. We awarded the bid for propane to Nolan Gas at \$1.44 per gallon, a 22-cent increase over last year. We awarded the bid for diesel fuel to Main Care at tank car price plus \$0.1993 cents per gallon for delivery. Tank car price is at a \$2.14 increase above last year. We awarded the bid for gasoline to Main Care at tank car price plus \$0.2589 cents per gallon for delivery. Tank car price is at a \$1.90 increase above last year. We authorized receipt of the remainder of ARPA funding to total \$9,165,716. All funds are committed at this time. The GC Youth Fair begins this Thursday, July 28 and runs through Sunday. There will be no admission fee again this year making ours the only free fair in NYS! I awarded 2 Speenburgh grants to the RC Sportsmans Club this month. The first helps with the cost to provide materials for the childrens archery program for 75 kids. The second will establish a new program for .22 safety and target shooting. The C-A trap shooting team from Coxsackie Sportsman Club, another group I sponsor, finished 1st place overall in the Varsity 1A Conference at the NYS High School Clay Target League Shoot in June. Congratulations to them on safely becoming State Champs!

**Councilmember VanEtten:** I'm just curious, Moms Meals, is that a private company or is that a volunteer organization?

**County Legislator Linger:** No, it's a company actually out of Iowa. They're called Pure Foods is the parent company and this is a DBA named Moms Means, but they're pretty big. They're nationwide and what they'll do is they'll provide frozen meals so they'll deliver once or twice a week to a household.

**Supervisor Ruso:** One of those through Hello Fresh or one of those places.

**County Legislator Linger:** Similar, but we also now have to do now our due diligence and make sure that people are able to pick the box up and bring it in the house, they have freezer space, they have the ability to use a microwave. So there's some leg work that goes into it and we might have to swap some people who are receiving meals now and swap people in and out to make the numbers work. It's very difficult right now to get the volunteers.

**Councilmember VanEtten:** I'm sure even lifting up one of those boxes for somebody...

**Ellie Alfeld:** Even the volunteers' money that is returned to the volunteer for the gasoline covers that, but the wear and tear on their car.

**County Legislator Linger:** Some of these routes like Lexington for example, some of those routes are almost 100 miles a day just because of the mileage that they're covering.

**Ellie Alfeld:** The gas is fine. That reimbursement is good.

**County Legislator Linger:** Yeah, we're at \$0.60.

**Ellie Alfeld:** I did it when it was down to 40-some-odd cents, but then I figured out how much wear and tear the mileage was and I was going three trips a day into Albany.

**Supervisor Ruso:** Can you define for me the idea with an organization called the Justice Center? What is your definition of the Justice Center? It's clearly not the same thing.

**County Legislator Linger:** No, this is a combination name that we came up with only because of this building will house the District Attorney's Office, Public Defender's Office, and Office of Court Administration. So it's all three, a 'Justice Center.'

**Supervisor Ruso:** Clearly and significantly different.

The regular monthly meeting was held on Tuesday, July 19, 2022. There were 18 EMS calls in June for a total of 62 for this year 2022. We had 110 calls for all of 2021.
